In an era of heavy offshoring and other formulaic cost-cutting, it is inspiring to learn about people and organizations that follow a different model, and have the growth to prove there is more than one road to value creation. I recently sat down with FEI New York City chapter member, **John Madonia**, to discuss his role as

CFO of the Brooklyn Navy Yard Development Corporation.

**John, please tell us about yourself. What are your main duties at the Brooklyn Navy Yard Development Corporation?**

As Chief Financial Officer of the Brooklyn Navy Yard Development Corporation, I am responsible for all aspects of the fiscal health of the organization. This includes budget & cash flow; treasury, as well as interfacing with the City oversight agencies. Our current annual revenue is at \$40mm with approximately 5 million sq. ft. of space that we currently manage.

The Brooklyn Navy Yard Development Corporation (BNYDC) is the not-for-profit corporation that serves as the real estate developer and property manager of the Yard on behalf of its owner, the City of New York. Our mission is to fuel New York City's economic vitality by creating and preserving quality jobs, growing the City's modern industrial sector and its businesses, and connecting the local community with the economic opportunity and resources of the Yard. We provide businesses with the stability they need to invest, grow, and thrive and where diverse job-seekers can come to find a high-quality, middle-class job. **[Click for the full interview](#)**
